- SlipNOT[®] applied their non slip metal coating to AT&T's customer supplied vault covers, providing a high traction surface for pedestrians.

AT&T's contractor contacted a sales representative from **SlipNOT®** Metal Safety Flooring to coordinate and organize the manufacturing of the custom direct traffic vault covers. The slip resistant vault covers need to snuggly fit within the dimension of the traffic rated vault enclosure.


10 pieces of 3/16" x 38-13/16" x 41-3/4" steel plates with windows and notches were supplied to the contractor for installation on the PW/AT&T 36x60 H-44 Direct Traffic Vaults. *Slip*NOT® supplied the cover plates with the medium Grade 2 slip resistant coating in a mill finish. *Slip*NOT® vault covers are available with the Grade 2 (Medium) slip resistant coating or the Grade 3 (Coarse) slip resistant surface.
